	DO WITH YOUR PERSONAL INFORMATION?

Effective 9/4/2020

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- · account balance and payment history
- · credit history and credit score

When you are no longer our member, we continue to share your information as described in this notice.

How?

All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies share their member's personal information; the reasons Interfaith Federal Credit Union chooses to share; and whether you can limit this sharing.

Important Privacy Choices for Consumers – [SB 1 Notice]

You have the right to control whether we share some of your personal information. Please read the following information carefully before you make your choices below.

Your Rights

You have the following rights to restrict the sharing of personal and financial information with outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about some other products and services.

Your Choices

Restrict Information Sharing With Other Companies We Do Business With to Provide Financial Products And Services: Unless you say "No" we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you.

Personal Information

When you visit interfaithfcu.org, we automatically receive and store certain types of information, such as the content you view, the date and time you view this content, the products you purchase, or your location information associated with your IP address. We use the information we collect to serve you more relevant advertisements (referred to as "Retargeting"). This is statistical information used to monitor the usage of our website and for advertising purposes. This information does not include personal information.

Cookies:

As you browse interfaithfcu.org, advertising cookies will be placed on your computer to help us predict your interests. Our display advertising partner, AdRoll, then enables us to present you with retargeting advertising on other sites based on your previous interaction with **interfaithfcu.org**. The techniques our partners employ do not collect per-sonal information such as your name, email address, postal address or telephone number.
